**RESOLUTION NO. 196-2019**

**DECLARING THE ANNUAL BUDGET FOR CALENDAR  
YEAR 2019 OF DASOL, PANGASINAN INVOLVING A  
TOTAL APPROPRIATION OF P117,964,268.24  
OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Dasol, Pangasinan submitted its Annual Budget for Calendar Year 2019 involving total appropriations of **P117,964,268.24** which was approved on December 3, 2018 through Appropriation Ordinance No. 161, S-2018;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. The projects funded under the 20% of the Annual Internal Revenue Allotment for development projects (20% Development Fund) shall be subject to the provisions of DILG and DBM JMC No. 2017-1 dated February 22, 2017 re "Updated Guidelines on the Appropriation and Utilization of the twenty percent (20%) of the Annual Internal Revenue Allotment for Development Projects";

2. All programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2019 Annual Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM Joint Memorandum Circular No. 1, S-2007 dated 08 March 2007;
3. All procurements to be undertaken shall be subject to the pertinent provisions of RA No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;
4. The full implementation of the Fourth Tranche Compensation Adjustment to all municipal officials and employees shall be subject to the provisions of Local Budget Circular No. 118 of the Department of Budget and Management dated January 15, 2019;
5. The grant of Clothing/Uniform Allowance to municipal officials and employees shall be subject to the provisions of Budget Circular No. 2018-1 of the Department of Budget and Management dated March 08, 2018;
6. The appropriation for payment of Terminal Leave Benefits of retired LGU personnel shall be subject to the provisions of DBM Budget Circular No. 2016-2 dated March 29, 2016 re: Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits, which provides for the new constant factor stated under Item 3.1 thereof;
7. The items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with RA No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Risk Reduction and Management Fund (LDRRMF) and that 30% shall be set as Quick Response Fund; *and*
8. The excess appropriation for Personal Services shall be subject to the provisions of Section 325 (a) of RA 7160; *and*

9. The grant of step increment to some municipal officials and employees shall be in accordance with CSC-DBM Joint Circular No. 1, S-2012 dated September 3, 2012 and CSC-DBM Joint Circular No. 01, S-2016 dated January 27, 2016. The appropriation for salaries of the following employees should therefore be adjusted as follows:
