**RESOLUTION NO. 198-2019**

**DECLARING THE ANNUAL BUDGET FOR CALENDAR  
YEAR 2019 OF MABINI, PANGASINAN INVOLVING A  
TOTAL APPROPRIATION OF P123,616,101.00  
OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Mabini, Pangasinan submitted its Annual Budget for Calendar Year 2019 involving total appropriations of **P123,616,101.00** which was approved on December 3, 2018 through Appropriation Ordinance No. 3, S-2018;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. The full implementation of the Fourth Tranche Compensation Adjustment for Local Government Personnel shall be subject to the provisions of Local Budget Circular No. 118 of the Department of Budget and Management dated January 15, 2019, specifically Sub-Item 5.2 thereof;

2. The grant of step increment to some municipal officials and employees shall be in accordance with CSC-DBM Joint Circular No. 1, S-2012 dated September 3, 2012;
3. The items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with RA No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Risk Reduction and Management Fund (LDRRMF) and that 30% shall be set as Quick Response Fund;
4. The projects funded under the 20% of the Annual Internal Revenue Allotment for development projects (20% Development Fund) shall be subject to the provisions of DILG and DBM JMC No. 2017-1 dated February 22, 2017 re "Updated Guidelines on the Appropriation and Utilization of the twenty percent (20%) of the Annual Internal Revenue Allotment for Development Projects" and DILG Memorandum Circular No. 2010-138 dated December 2, 2010 entitled "Use of the 20% Component of the Annual Internal Revenue Allotment Share";
5. All procurements to be undertaken shall be subject to the pertinent provisions of RA No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations; *and*
6. The appropriation for Other Personnel Benefits should be transferred to Personal Services pursuant to Local Budget Circular No. 98 dated October 14, 2011. The same shall be disbursed in accordance with the rules and regulations to be issued by the proper authorities.

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the same in order provided that the above-findings shall be complied with by the municipality;

**NOW, THEREFORE**, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Antonio F. Sison and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Arth Bryan C. Celeste, duly seconded, it was –




