**APPROVING RESOLUTION NO. 53, S-2021 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED “APPROVING THE UTILIZATION OF THE UNEXPENDED QUICK RESPONSE FUND OF 2017 OF THE 5% LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND FOR THE PROGRAMS, PROJECTS AND ACTIVITIES IN THE AMOUNT OF TWO MILLION TWO HUNDRED EIGHTY HREE THOUSAND THREE HUNDRED TWENTY TWO PESOS AND FIFTY CENTAVOS (P2,283,322.50) OF THE MUNICIPALITY OF VILLASIS, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Villasis, Pangasinan submitted its Resolution No. 53, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Municipal Disaster Risk Reduction and Management Council has identified programs/projects to be funded under the unexpended QRF of 2017 of the 5% LDRRM Fund, which was adopted and endorsed to the Sangguniang Bayan of Villasis on November 3, 2021 through MDRRMC Resolution 02-2021;

**WHEREAS**, the unexpended QRF of 2017 is intended to fund projects/activities to address COVID-19 pandemic which is in accordance to Section 2.5.6 of Local Budget Circular No. 124 dated March 26, 2020;

**WHEREAS**, however, Section 6.5 of JMC No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund) states that "...the unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a Revised AIP as approved by the local sanggunian and Local Chief Executive upon recommendation of the LDRRMC in accordance with the approved LDRRMP";

**WHEREAS**, the LGU of Villasis, Pangasinan shall submit a Revised AIP-CY 2021, Local Development Council Resolution endorsing the Revised AIP, and Sangguniang Bayan resolution adopting/approving the same;
