RESOLUTION NO. 199-2019

DECLARING MUNICIPAL ORDINANCE NO. 10, S-2019 OF THE SANGGUNIANG BAYAN OF AGUILAR, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING MORAL RECOVERY PROGRAM IN THE MUNICIPALITY OF AGUILAR, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Municipal Ordinance No. 10, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 16 of RA 7160; Preamble of the 1987 Philippine Constitution; Proclamation No. 62 dated September 30, 1992 and Executive Order No. 319 (Institutionalizing the Moral Recovery Program in all Government Departments, Agencies and Government-Owned and Controlled Corporations Through the Establishment of Integrity Circles);

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with Section 59 of RA 7160;
