RESOLUTION NO. 199-2020

DECLARING THE ANNUAL BUDGET FOR CALENDAR YEAR 2020 OF THE CITY OF ALAMINOS, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P704,481,166.00 OPERATIVE IN PART

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Annual Budget for Calendar Year 2020 involving total appropriations of **P704,481,166.00** which was approved on December 10, 2019 through Appropriation Ordinance No. 2019-04 and approved by the City Mayor on December 16, 2019;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. The appropriation for the Representation and Transportation Allowance for Medical Specialist II with Salary Grade 23 shall not be allowed. The Sangguniang Panlalawigan further reiterates its finding in the Annual Budget for CY 2019 that said position is not a City Government Assistant Department Head and not included among the positions entitled to RATA under existing circulars;
2. All programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2020 Annual Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM Joint Memorandum Circular No. 1, S-2007 dated 08 March 2007;

3. The projects funded under the 20% of the Annual Internal Revenue Allotment for development projects (20% Development Fund) shall be subject to the provisions of DILG and DBM JMC No. 2017-1 dated February 22, 2017 re “Updated Guidelines on the Appropriation and Utilization of the twenty percent (20%) of the Annual Internal Revenue Allotment for Development Projects” and DILG Memorandum Circular No. 2010-138 dated December 2, 2010, entitled :Use of the 20% Component of the Annual Internal Revenue Allotment Shares;
4. All procurements to be undertaken shall be subject to the pertinent provisions of RA No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;
5. The appropriation and disbursement for Performance-Based Bonus (PBB) for all officials and employees of the city shall be subject to the provisions of DILG-DBM Joint Memorandum Circular No. 2017-4 dated June 7, 2017;
6. The purchase of motor vehicles shall be subject to the provisions of Budget Circular No. 2017-1 of the Department of Budget and Management dated April 26, 2017 amending Budget Circular No. 2016-5 entitled “Revised Guidelines on the Acquisition and Use of Government Motor Vehicles” dated August 22, 2016; *and*
7. The grant of step increment to some municipal officials and employees shall be in accordance with CSC-DBM Joint Circular No. 01, S-2012 dated September 3, 2012 and CSC-DBM Joint Circular No. 01, S-2016 dated January 27, 2016. The appropriation for salaries of the following employees should therefore be adjusted as follows:




