## PROVINCIAL RESOLUTION NO. 2-2019

ENDORSING TO THE DEPARTMENT OF HEALTH THE UPGRADING CAPABILITY OF EASTERN PANGASINAN DISTRICT HOSPITAL FROM LEVEL I TO LEVEL II HOSPITAL

WHEREAS, the Eastern Pangasinan District Hospital is presently categorized as a Level I Hospital operating under a 150-authorized bed capacity;

**WHEREAS,** the Eastern Pangasinan District Hospital has recently applied for a License to Operate a Health Facility to the Bureau of Health Facilities and Services, Department of Health (DOH), for the upgrading of accreditation of the hospital from Level I to Level II with a requirement of a Tertiary Clinical Laboratory;

WHEREAS, the Province of Pangasinan has been continuously focusing on the upgrading of its provincial government hospitals with the aim of further enhancing its efficient and equitable delivery of health services to the people, especially the poor and the needy;

**WHEREAS,** if upgraded as Level II Hospital, the Eastern Pangasinan District Hospital can provide a more sufficient and higher level of medical and health services to the different localities of the 6<sup>th</sup> District of Pangasinan;

**WHEREAS**, the Sangguniang Panlalawigan strongly supports the Eastern Pangasinan District Hospital in its efforts to upgrade its facilities from Level I to Level II as prescribed by the DOH;
