PANGASINAN IN THE AMOUNT OF SIX MILLION NINETY-ONE **THOUSAND** HUNDRED THREE SEVENTY-FIVE (P6,091,375,000.00) PESOS"

**WHEREAS**, the Sangguniang Bayan of Malasiqui, Pangasinan submitted its SB Resolution No. 154-2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council – Executive Committee of Malasiqui, Pangasinan has prepared the municipality's Supplemental Investment Program No. 02 for CY 2019. This was endorsed by the Council thru MDC Resolution No. 02-2019 dated October 1, 2019 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 154-2019 dated October 2, 2019;

**WHEREAS**, said Supplemental Investment Program, which has a total investment requirement of P6,091,375.00, covers augmentation funds for Personal Services, MOOE, Capital Outlay of various offices, and other development projects of the LGU;
