**PROVINCIAL RESOLUTION NO. 200-2021**

**URGING THE PROVINCIAL INTER-AGENCY TASK FORCE TO PRESENT THE PROPOSED COVID-19 VACCINATION PLAN FOR THE PROVINCE OF PANGASINAN, IN AID OF LEGISLATION**

**WHEREAS**, a vaccination plan is essential to ensure the readiness of the government in the implementation of an equitable, fair and systematic way of vaccine distribution in Pangasinan;

**WHEREAS**, the Sangguniang Panlalawigan, during its earlier Question Hour conducted today, the Provincial Inter-Agency Task Force participated in by Dr. Ana Ma. Teresa S. de Guzman, Provincial Health Officer, and Col. Rhodyn Luchinvar O. Oro, Provincial Disaster Risk Reduction and Management Officer, reported initial and relevant information for the vaccine rollout plan of the Province;

**WHEREAS**, the Provincial Inter-Agency Task Force pronounced that the Province is aiming to set a target figure to achieve herd immunity;

**WHEREAS**, some sectors of society have been identified by the Provincial Inter-Agency Task Force to receive the vaccine first to include public health workers, indigent senior citizens, remaining senior citizens, indigent population, and uniformed personnel;

**WHEREAS**, the vaccination plan is an essential government's effort to ensure that a significant number of Pangasinenses are vaccinated as soon as the vaccines are available;

**WHEREAS**, the Sangguniang Panlalawigan in collaboration with the Provincial Inter-Agency Task Force would like to help through the enactment and passage of ordinances and resolutions for the implementation of an effective vaccination plan that would redound to the socio-economic benefit of the people of Pangasinan;



**WHEREFORE**, in view of the foregoing, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –


