PROVINCIAL RESOLUTION NO. 201-2020

URGING ALL LOCAL GOVERNMENT UNITS OF PANGASINAN TO INCLUDE MUNICIPAL MAYORS AND BARANGAY CAPTAINS TO TEMPORARILY DISCOURAGE THE HOLDING OF PUBLIC AND PRIVATE ASSEMBLIES AND GATHERINGS IN THEIR AREAS OF JURISDICTION

WHEREAS, Department of Health Advisory signed by Secretary Francisco T. Duque III last February 7, 2020 strongly urges the public to avoid attending, participating in, and organizing events that draw a huge number of attendees due to the ongoing threat of the spread of the 2019 Novel Coronavirus (nCoV);

WHEREAS, the said advisory further minimizes the risk of contracting the 2019 nCoV by advising the public to avoid crowded places and continue to practice self-protection measures;

WHEREAS, the people of Pangasinan especially the higher authorities must be alert and vigilant to the threat that might be brought by the nCoV in the Province especially now that the World Health Organization (WHO) has declared a global health emergency due to its outbreak;

WHEREAS, although the Province of Pangasinan is at present considered as an nCoV free as confirmed and validated by the Regional and Provincial Health Officials during the Question Hour of the Sangguniang Panlalawigan on its February 10, 2020 Regular Session towards the preparation undertaken to combat nCoV, the august Body would not like to take the risks by instituting some legislative precautionary measures to prevent the entry of the acute respiratory disease;

WHEREFORE, on motion of SP Member Jeremy Agerico B. Rosario and co-authored by all Members of the Sangguniang Panlalawigan, duly seconded, it was –


RESOLVED, by the Sangguniang Panlalawigan in session assembled to urge, as they are hereby urged, all Local Government Units of Pangasinan to include Municipal Mayors and Barangay Captains to temporarily discourage the holding of public and private assemblies and gatherings in their areas of jurisdiction;

RESOLVED, FURTHER that copies of this resolution be furnished to all Local Chief Executives and Barangay Captains of the Province of Pangasinan, for their information and guidance.
