PROVINCIAL RESOLUTION NO. 201-2021

REQUESTING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO EXTEND FINANCIAL ASSISTANCE TO AUGMENT AND SUPPORT THE MAINTENANCE OF PROVINCIAL BORDER CHECKPOINTS MANNED BY LAW ENFORCEMENT AGENCIES

WHEREAS, provincial border checkpoints remain to be operating in some areas even the Province is now placed under the Modified General Community Quarantine (MGCQ) status;

WHEREAS, law enforcement agencies led by the Philippine National Police have been continually manning the provincial border checkpoints to enforce directives from the national government to further contain the spread of COVID-19;

WHEREAS, the conduct of provincial border checkpoint operations and inspections is essential to monitor the passage of authorized persons outside residence (APORs), essential and frontline service workers, and other persons with passes or pertinent documents specially during this period that active COVID-19 cases have been increasing in the Province;

WHEREAS, the Provincial Government of Pangasinan fully supports the noble undertaking of the law enforcement agencies in manning the provincial border checkpoints of Pangasinan in order to lessen COVID-19 cases in the Province;

WHEREAS, the Sangguniang Panlalawigan deemed it necessary to seek the help of the Provincial Governor to extend financial assistance to sustain the maintenance of provincial border checkpoints in Pangasinan;




