**PROVINCIAL RESOLUTION NO. 202-2020**

**URGING ALL PUBLIC AND PRIVATE SCHOOL OFFICIALS  
OF THE PROVINCE OF PANGASINAN TO STRICTLY  
COMPLY WITH DepEd ORDER NO. 15-2020 ON TEMPORARY  
SUSPENSION OF EVENTS AND ACTIVITIES IN THEIR AREAS  
OF RESPONSIBILITY**

**WHEREAS**, the Department of Education (DepEd) issued Department Memorandum No. 15, S-2020 directing the postponement of all national and regional activities involving learners and/or teachers for the month of February;

**WHEREAS**, the DepEd directive is in consonance with the health advisory of the Department of Health strongly urging the public to avoid crowded places in order to reduce exposure to the 2019 Novel Coronavirus (nCoV) in the Province;

**WHEREAS**, the Sangguniang Panlalawigan fully supports the implementation of the said DepEd order as it reduces the chance of entry of the acute respiratory disease and minimizes the risk of contracting the same;

**WHEREAS**, in the aftermath of the spread of the disease in almost all parts of the world, necessary steps must be undertaken to safeguard public health and safety;

**WHEREAS**, this measure aims to keep Pangasinenses safe from the threats of this infectious disease especially the children by urging all public and private school officials to strictly comply with DepEd Order No. 15-2020;


