DECLARING ORDINANCE 38, S-2021 OF SANGGUNIANG **BAYAN OF** ASINGAN, PANGASINAN, ENTITLED "AN **ORDINANCE GRANTING** ASSISTANCE TO **COLLEGE STUDENTS** FROM MUNICIPALITY OF ASINGAN, PANGASINAN IN THE AMOUNT OF FIVE THOUSAND PESOS (P5,000.00) EACH PER SEMESTER TO QUALIFIED INDIGENT BUT DESERVING COLLEGE STUDENTS WHO ARE ENROLLED AT ANY PANGASINAN STATE UNIVERSITY (PSU) CAMPUS, URDANETA CITY UNIVERSITY (UCU) AND UNIVERSITY OF PANGASINAN (UEP)" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Ordinance No. 38, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (5) (xi) of R.A. No. 7160;
