APPROVING RESOLUTION NO. 2021-577 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 7 FOR THE CALENDAR YEAR 2021 OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Balungao, Pangasinan submitted its Resolution No. 2021-577 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R. A. 7160;

**WHEREAS,** the Supplemental Investment Program No. 7 was endorsed by the Municipal Development Council to the Sangguniang Bayan for approval on December 29, 2021 through MDC Resolution No. 2021-11;

WHEREAS, subject Supplemental AIP with an investment requirement amounting to P934,000.00 covers the granting of Service Recognition Incentive (SRI) to municipal government employees of Balungao, Pangasinan;

**WHEREAS,** the Sangguniang Bayan enacted Supplemental Budget No. 4 for CY 2021 through Appropriation Ordinance No. 2021-05 dated December 29, 2021 to support the implementation of Supplemental Annual Investment Plan No. 7 of the municipality;
