**APPROVING RESOLUTION NO. 211-2021 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 05 CALENDAR YEAR 2021 INVOLVING AN AMOUNT OF TWO MILLION SEVEN HUNDRED THOUSAND PESOS (P2,700,000.00) IN THE 2021 GENERAL FUND PROPER SOURCED OUT FROM THE RETAINED EARNINGS OF FY 2020 AND UNDERESTIMATED INCOME OF FY 2021 FOR PURPOSES OF FUNDING THE VARIOUS PROGRAMS IN THE MUNICIPALITY OF ROSALES, PANGASINAN”**
