APPROVING RESOLUTION NO. 122, S-2019 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED "APPROVING THE THIRD SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) FOR FY 2019 OF THE MUNICIPALITY OF INFANTA, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Infanta, Pangasinan submitted its Resolution No. 122, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Infanta, Pangasinan had identified project in their Third Supplemental Investment Program for CY 2019 with a total investment requirement of P2,300,000.00. This was endorsed to the Sangguniang Bayan for approval on November 11, 2019 thru MDC Resolution No. 3, S-2019 and was favorably acted upon by the Sangguniang Bayan on November 18, 2019 thru SB Resolution No. 122, S-2019;

WHEREAS, the Third Supplemental Investment Program of the municipality covers the implementation of the Concreting of Local Access Road at Barangay Patima, Sitio Tinokol Main Road to Barangay Bamban, which will be funded from the 2019 Performance Challenge Fund (PCF), an award/incentive received by the municipality for passing the Seal of Good Local Governance in 2019;
