**APPROVING RESOLUTION NO. 20-085 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED “REALIGNING THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (P500,000.00) FROM PROJECT TITLED: 1) CONDUCT SEMINARS AND DRILL (P200,000.00), 2) CONDUCT OF FIRE, FIRST-AID AND RECUELYMPICS (P200,000.00), AND 3) TYPHOON MONITORING AND STANDBY RESPONSE, ACTUAL RESPONSE (P100,000.00) TO PROJECT TITLED: 1) PROCUREMENT OF RELIEF GOODS FOR THE TYPHOON VICTIMS OF CAGAYAN PROVINCE AMOUNTING TO P500,000.00”**

**WHEREAS**, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 20-085 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the City Development Council – Executive Committee of San Carlos City, Pangasinan proposed to the Sangguniang Panlungsod the realignment of the sum of P500,000.00 from the 2020 Local Disaster Risk Reduction and Management Funds. This is supported by the City Disaster Risk Reduction and Management Council Resolution No. 07-2020 dated November 17, 2020. This was endorsed by the Council thru CDC Resolution No. 20-20 (Series of 2020) dated November 18, 2020 to the Sangguniang Panlungsod for approval;
