

PROVINCIAL ORDINANCE NO. 211-2017

AN ORDINANCE AUTHORIZING THE PROPOSED BORROWING OF THE PROVINCIAL GOVERNMENT OF PANGASINAN IN THE AMOUNT OF THREE HUNDRED FIFTY MILLION PESOS ONLY (P350,000,000,00) TO FUND THE VARIOUS STRATEGIC AND PRIORITY PROGRAMS AND PROJECTS OF THE PROVINCE

BE IT ENACTED, as it is hereby enacted by the Sangguniang Panlalawigan, in session assembled that:

SECTION 1. The Provincial Governor, Hon. Amado I. Espino, III, in representation of the Province, hereinafter referred to as the "Provincial Government of Pangasinan", is hereby authorized to enter into Term Loan with the Land Bank of the Philippines, Pangasinan Lending Center, in accordance with Section 297 of Republic Act No. 7160 or the Local Government Code, in the amount of THREE HUNDRED FIFTY MILLION PESOS ONLY (P350,000,000.00) under the terms and conditions herein set forth and such other terms and conditions as may be agreed upon with any person, corporation or entity for the purpose of funding priority project/s, and subject to the requirements under Section 123 of Republic Act No. 7653 as implemented by the Bangko Sentral ng Pilipinas Circular No. 402. In this connection, the Provincial Governor, Hon. Amado I. Espino, III, shall have the full power and authority to represent the Provincial Government of Pangasinan in negotiating the terms and conditions for the said borrowing and in signing, executing and delivering such agreements, contracts, deeds, papers and documents as may be necessary and proper for the full and total implementation of the authority herein granted.

SECTION 2. The said priority projects herein specified to achieve further development and progress and in order to provide better services to Pangasinenses is/are hereby certified to be a local infrastructure and/or other socio-economic development projects in accordance with the approved local development plan and public investment program for the period CY 2016 or for the current year 2017 of the Provincial Government of Pangasinan and it is supported by a final approval of the Sangguniang Panlalawigan.



be necessary, self-liquidating, income producing development projects, in accordance with local development plan and public investment program of the Province.

SECTION 5. The Province hereby appropriates the entire proceeds of the borrowing exclusively to finance the said projects and other financial obligations relative thereto.

SECTION 6. Any Ordinance or parts thereof, inconsistent with this enactment is hereby repealed or amended accordingly.

SECTION 7. This Ordinance shall take effect upon its publication and compliance with all procedures required under Republic Act No. 7160 of an ordinance for its validity, including the affixation of signatures of the Sangguniang Panlalawigan Members, in concurrence thereto, composing at least a majority thereof, out of the total 15 members, on all pages of this Ordinance.

RESOLVED FURTHER, that copies of this Ordinance be furnished the Honorable Governor, Amado I. Espino, III, the Provincial Treasurer, the Provincial Accountant, the Provincial Budget Officer, the Provincial Auditor, all of the Province of Pangasinan, Land Bank of the Philippines, Bangko Sentral ng Pilipinas and other concerned agencies, for their information and appropriate action.
