## **RESOLUTION NO. 212-2019**

DECLARING RESOLUTION NO. 2018-21 OF THE SANGGUNIANG BAYAN OF SAN MANUEL. **"ADOPTING** PANGASINAN, ENTITLED THE COMPREHENSIVE LAND USE PLAN (CLUP) OF THE MUNICIPALITY OF SAN MANUEL, PANGASINAN" AS CONFERRED POWERS WITHIN THE OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Manuel, Pangasinan submitted its Resolution No. 2018-21 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, and Provincial Land Use Committee, have conducted initial review and study on said resolution and found out that the same was enacted pursuant to Section 447 (a) (2) (vii) of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Comprehensive Land Use Plan (CLUP) of San Manuel, Pangasinan had undergone the technical review by the Provincial Land Use Committee (PLUC) of the Province of Pangasinan pursuant to the guidelines of Memorandum Circular No. 2000-130 of the Department of the Interior and Local Government as embodied in Section 2 (b) of Executive Order No. 72, S-1993;
