**APPROVING RESOLUTION NO. 20-083 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "APPROVING THE INCLUSION OF PROJECT TITLED: CONSTRUCTION OF EVACUATION CENTER AND QUARANTINE & ISOLATION FACILITY IN THE AMOUNT OF FORTY TWO MILLION EIGHT HUNDRED THOUSAND PESOS (P42,800,000.00) IN THE REVISED ANNUAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2020 OF THE CITY OF SAN CARLOS, PROVINCE OF PANGASINAN"**

**WHEREAS**, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 20-083 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the City Development Council-Executive Committee of San Carlos City proposed to the Sangguniang Panlungsod the inclusion of the project, Construction of Evacuation Center and Quarantine and Isolation Facility in the revised Annual Investment Program (AIP) for CY 2020. This was endorsed by the Council, through CDC Resolution No. 19-20, S-2020 dated November 6, 2020 to the Sangguniang Panlungsod for approval. The Sangguniang Panlungsod approved said endorsement through Sangguniang Panlungsod Resolution No. 20-083 dated November 6, 2020;

**WHEREAS**, the COVID-19 related projects will be charged from the Unutilized, 2017-2019, Local Disaster Risk Reduction and Management Fund Balances, from CYs 2017 to 2019, of the LGU in the amount of P42,800,000.00;




