RESOLUTION NO. 214-2022

DECLARING MUNICIPAL ORDINANCE NO. 121, S-2021 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED "AN **ORDINANCE CREATING** PLANTILLA POSITIONS IN THE LOCAL GOVERNMENT UNIT SAN NICOLAS, PANGASINAN **SPECIFYING PROVIDING OUALIFICATION** AND **FUNCTIONS** AND APPROPRIATION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Municipal Ordinance No. 121, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 76 and 447 (a) (viii), (5) of R.A. No. 7160;

WHEREAS, however, the Sangguniang Bayan shall (a) revise the experience requirement of the position of Nurse II from at least two (2) years relevant experience to one (1) year relevant experience; (b) enact an ordinance creating the Office of the Municipal Labor and Employment Officer and Municipal Environment and Natural Resources Office; and (c) the position title of the head of the new offices should be Government Department Head I (Municipal Labor and Employment Officer) and (Municipal Environment and Natural Resources Officer) to be entitled to representation and transportation allowance;
