**APPROVING RESOLUTION NO. 229, S-2019 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF BAUTISTA, PROVINCE OF PANGASINAN UNDER MDC RESOLUTION NO. 6, SERIES OF 2019 FUNDED FROM THE SUPPLEMENTAL BUDGET NO. 3 FOR CY 2019 AMOUNTING TO ONE MILLION EIGHTY-FOUR THOUSAND TWO HUNDRED EIGHTY EIGHT PESOS AND 32/100 (P1,084,288.32)”**

**WHEREAS**, the Sangguniang Bayan of Bautista, Pangasinan submitted its Resolution No. 229, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Bautista, Pangasinan has formulated the municipality’s Supplemental Annual Investment Program No. 3 for CY 2019 and endorsed to the Sangguniang Bayan for approval thru MDC Resolution No. 06, S-2019 dated December 9, 2019. The Sangguniang Bayan approved the Supplemental Annual Investment Program No. 3 on December 16, 2019 thru Resolution No. 229, S-2019. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

**WHEREAS**, the Supplemental Annual Investment Program No. 3 with an investment requirement amounting to P1,084,288.32 covers the implementation of the grant of the One-Time Service Recognition Incentive for FY 2019;


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
