APPROVING RESOLUTION NO. 54, S-2021 OF THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 4 FOR FY 2021 OF THE MUNICIPALITY OF BUGALLON, PROVINCE OF PANGASINAN INVOLVING THE AMOUNT OF ONE MILLION ONE HUNDRED FORTY THOUSAND PESOS (P1,140,000.00)"

WHEREAS, the Sangguniang Bayan of Bugallon, Pangasinan submitted its SB Resolution No. 54, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R.A. 7160;

WHEREAS, the Local Development Council of Bugallon, Pangasinan had identified items in their Supplemental Investment Program No. 4 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on October 12, 2021 through MDC Resolution No. 7, Series of 2021;

WHEREAS, the said Supplemental Investment Program of the municipality covers fund augmentation for the Maintenance and Other Operating Expenses and Capital Outlay of some LGU offices and implementation of various projects for the Bugallon Memorial Park and Public Cemetery;
