WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Agno, Pangasinan submitted its Supplemental Budget No. 08 for Calendar Year 2021 involving total appropriations of P720,000.00, which was enacted on December 31, 2021 through Appropriation Ordinance No. 2021-09;

1. That the reversion of savings from Maintenance and Other Operating Expenses shall be in accordance with the provisions of Section 336 of R.A. No. 7160 (Use of Appropriated Funds and Savings); and
2. That the grant of Gratuity Pay to Contract of Service and Job Workers in the municipality for FY 2021 shall be in accordance with Budget Circular No. 2021-5 dated December 31, 2021.
