APPROVING RESOLUTION NO. 279, S-2021 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 6 FOR CY 2021 OF THE MUNICIPAL GOVERNMENT OF BINMALEY, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Resolution No. 279, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R. A. 7160;

WHEREAS, the Local Development Council of Binmaley, Pangasinan had identified items in their Supplemental Investment Program No. 6 for CY 2021 and endorsed the same to the Sangguniang Bayan for approval on December 27, 2021 through MDC Resolution No. 7, Series of 2021;

WHEREAS, subject Supplemental AIP covers fund augmentation for the Personal Services (granting of Service Recognition Incentive to municipal officials and employees) and Maintenance and Other Operating Expenses of some municipal offices of the LGU;
