## **PROVINCIAL ORDINANCE NO. 223-2019**

### **AN ORDINANCE RENAMING THE PROVINCIAL POPULATION OFFICE TO PROVINCIAL POPULATION, COOPERATIVE AND LIVELIHOOD DEVELOPMENT OFFICE**

**WHEREAS**, Provincial Ordinance No. 15-92, approved by the Sangguniang Panlalawigan on July 20, 1992, renamed the Provincial Population Responsible Parenthood into Provincial Population Office;

**WHEREAS**, since 2008, the Provincial Population Office has been managing and implementing the cooperative and livelihood development programs of the Province;

**WHEREAS**, the duties and function of the Cooperatives Officer are already being performed by the Provincial Population Office as cooperative and livelihood development are directly related to population development;

**WHEREAS**, one of its major functions is the inclusion of the full administrative control of the provincewide livelihood and credit assistance program of the Province;

**WHEREAS**, there is a need therefore to integrate the duties and functions of the Cooperatives Officer into the Provincial Population Office and to include the same to the name of the office;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr., duly seconded,

*Be it enacted by the Sangguniang Panlalawigan in session assembled:*

**SECTION 1.** The Office of the Provincial Population Office is hereby renamed as Provincial Population, Cooperative and Livelihood Development Office.

**SECTION 2.** The following duties and functions of the Cooperatives Officer pursuant to Section 487 of the Local Government Code of 1991 shall be included as additional functions of the Provincial Population Office, more particularly it shall:


- a. Assist in the organization of cooperatives;
- b. Provide technical and other forms of assistance to existing cooperatives to enhance their viability as an economic enterprise and social organizations; *and*
- c. Assist cooperatives in establishing linkages with government agencies and non-government organizations involved in the promotion and integration of the concept of cooperatives in the livelihood of the people and other community activities.

**SECTION 3. Effectivity Clause** – This Ordinance shall take effect upon approval.
