PROVINCIAL RESOLUTION NO. 224-2021

ENDORSING TO THE DEPARTMENT OF HEALTH THE APPLICATION FOR A PERMIT TO CONSTRUCT A TWO-STOREY DIALYSIS CLINIC AND PUBLIC HEALTH BUILDING AT THE LINGAYEN DISTRICT HOSPITAL, PROVINCE OF PANGASINAN

WHEREAS, the Lingayen District Hospital, one of the 14 hospitals operated by the Provincial Government of Pangasinan, caters to patients coming from the different municipalities and other areas from nearby localities of the 2nd District of Pangasinan;

WHEREAS, at present, there is a significant increase in the number of patients being serviced by the hospital;

WHEREAS, the Provincial Government of Pangasinan through the Lingayen District Hospital intends to construct a two-storey dialysis clinic and public health building which is a great step in the quest to prolong and improve the quality of life of persons suffering from kidney problems through affordable cost;

WHEREAS, the Lingayen District Hospital and its medical staff are capable in running and sustaining the operations of the Dialysis Center;

WHEREAS, in line with the main thrusts of the present administration to have a mass-based health care program to accommodate all people especially the less fortunate sector of society, there is a need to support the plan of the Lingayen District Hospital to provide a more sufficient and higher level of medical and health services to its patients by its construction of a two-storey dialysis clinic and public health building;

WHEREAS, prior to the issuance of a license to construct, a Provincial Board Resolution is required by the Department of Health to facilitate the issuance of the permit to construct a health facility;


