RESOLUTION NO. 227-2019

**DECLARING THE ANNUAL BUDGET FOR CALENDAR
YEAR 2019 OF BUGALLON, PANGASINAN INVOLVING A
TOTAL APPROPRIATION OF P197,600,054.00
OPERATIVE IN ITS ENTIRETY**

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Annual Budget for Calendar Year 2019 involving total appropriations of **P197,600,054.00** which was approved on December 21, 2018 through Appropriation Ordinance No. 2018-04;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. The full implementation of the Fourth Tranche Compensation Adjustment for municipal officials and employees shall be subject to the provisions of Local Budget Circular No. 118 of the Department of Budget and Management dated January 15, 2019;

2. The projects funded under the 20% of the Annual Internal Revenue Allotment for development projects (20% Development Fund) shall be subject to the provisions of DILG and DBM JMC No. 2017-1 dated February 22, 2017 re “Updated Guidelines on the Appropriation and Utilization of the twenty percent (20%) of the Annual Internal Revenue Allotment for Development Projects” and DILG Memorandum Circular No. 2010-138 dated December 2, 2010, entitled “Use of the 20% Component of the Annual Internal Revenue Allotment Shares”;
3. The items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with RA No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Risk Reduction and Management Fund (LDRRMF);
4. All procurements to be undertaken shall be subject to the pertinent provisions of RA No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;
5. The appropriation for RATA under the Municipal Engineer’s Officer will be adjusted from P153,000.00 to P76,500.00;
6. The grant of step increment to elective officials shall be in accordance with CSC-DBM Joint Circular No. 01, S-2016 dated January 27, 2016. The salary therefore of the ABC President shall be adjusted from P864,624.00 to P850,740.00;
7. The ordinance on the abolition and creation of new positions shall be submitted, enumerating the qualifications, duties and responsibilities of said position. Likewise, a separate ordinance shall be submitted authorizing the transfer of two (2) drivers under the Mayor’s Office to the Municipal Health Office; *and*
8. The disbursement of Performance-Based Bonus (PBB) for officials and employees from the municipality shall be in accordance with the DILG-DBM Joint Memorandum Circular No. 2018-1 dated October 11, 2018.


