PROVINCIAL RESOLUTION NO. 228-2022

AUTHORIZING THE HONORABLE GOVERNOR, AMADO I. ESPINO III, FOR THE PROCUREMENT OF ONE (1) UNIT OF MOTOR VEHICLE FOR USE BY THE PROVINCIAL GOVERNMENT OF PANGASINAN

WHEREAS, the Provincial Government of Pangasinan is in need of a motor vehicle which shall be used for the management and staff of the Food Processing Facilities of the Provincial Population, Cooperative and Livelihood Development Office;

WHEREAS, the Provincial Government of Pangasinan intends to procure a motor vehicle for the said office with a total cost of P2,500,000.00, as herein specified, to wit:


WHEREAS, the procurement of the vehicle is beneficial to the Province as a means of further enhancing the delivery of services to the people of Pangasinan;

NOW, THEREFORE, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was –


