**RESOLUTION NO. 229-2019**

**DECLARING THE ANNUAL BUDGET FOR CALENDAR  
YEAR 2019 OF MANGATAREM, PANGASINAN  
INVOLVING A TOTAL APPROPRIATION OF  
P227,529,161.00 OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Mangatarem, Pangasinan submitted its Annual Budget for Calendar Year 2019 involving total appropriations of **P227,529,161.00** which was approved on November 21, 2018 through Appropriation Ordinance No. 02, S-2018;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. The full implementation of the Fourth Tranche Compensation Adjustment effective January 1, 2019 for all municipal officials and employees shall be subject to the provisions of Local Budget Circular No. 118 of the Department of Budget and Management dated January 15, 2019;

2. The grant of step increment to some municipal officials and employees shall be in accordance with CSC-DBM Joint Circular No. 1, S-2012 dated September 3, 2012;
3. The appropriation for salaries of Mr. Arturo S. Bugayong, Administrative Aide IV (Clerk II) under the Office of the Municipal Civil Registrar shall be adjusted from SG 4/5 P179,556.00 to SG 4/5 P147,156.00 per annum;
4. The purchase of Motor Vehicle shall be subject to the provisions of Administrative Order No. 14 dated December 10, 2018 amending Administrative Order No. 15 dated May 25, 2011, and DILG Memorandum Circular No. 2014-155 as amended by DILG Memorandum Circular No. 2015-52 dated May 11, 2015, and Budget Circular No. 2017-1 of the Department of Budget and Management dated April 26, 2017 re: Amending Budget Circular No. 2016-05 entitled "Revised Guidelines on the Acquisition and Use of Government Motor Vehicles" dated August 22, 2016;
5. The utilization of all appropriations for Capital Outlay, shall, as may be applicable, be subject to the authorization of the Sanggunian on the list of projects to be implemented as ruled by the Supreme Court in the case of Hon. Gabriel Luis Quisumbing, et. al. versus Hon. Gwendolyn F. Garcia, et. al., G.R. No. 175527, December 8, 2008;
6. The effect of the adjusted FY 2019 Internal Revenue Allotment (IRA) shares pursuant to Local Budget Memorandum No. 77-B dated December 21, 2018, particularly the decrease of the IRA Share of the LGU amounting to P765,941.00, will necessitate the prioritization in the implementation of items of appropriations;
7. The appropriation for payment of Terminal Leave Benefits of retired LGU personnel shall be subject to the provisions of DBM Budget Circular No. 2016-2 dated March 29, 2016 re: Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits, which provides for the new constant factor stated under Item 3.1 thereof;
8. The items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with RA No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Risk Reduction and Management Fund (LDRRMF) and that 30% shall be set as Quick Response Fund;

9. All appropriations for development projects (20% development fund) shall be subject to the provisions of DILG-DBM Joint Memorandum Circular No. 2017-1 dated February 22, 2017 amending Joint Memorandum Circular No. 2011-1 dated April 15, 2011; *and*
10. All procurements to be undertaken shall be subject to the pertinent provisions of RA No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations.


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the same in order provided that the above-findings shall be complied with by the municipality;

**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare **OPERATIVE IN ITS ENTIRETY the Annual Budget for Calendar Year 2019 of Mangatarem, Pangasinan** as of January 1, 2019; provided, that the disbursement of appropriations as approved shall be subject to the existing accounting and auditing rules and regulations, and compliance with other pertinent laws, rules and regulations shall be the responsibility of the Municipal Government of Mangatarem;

**RESOLVED FURTHER**, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Mangatarem, Pangasinan, for its information and guidance.
