PROVINCIAL ORDINANCE NO. 229-2019

AN ORDINANCE TRANSFERRING SOME PLANTILLA POSITIONS IN THE DIFFERENT OFFICES IN THE PROVINCIAL GOVERNMENT OF PANGASINAN

WHEREAS, Section 76 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirement and financial capability, subject to the minimum standard and guidelines prescribed by the Civil Service Commission;

WHEREAS, Section 468 (a) (viii) of the same Code provides that the Sangguniang Panlalawigan has the power to determine the positions and salaries including allowances and other emoluments and benefits of employees of the provincial government;

WHEREAS, in the preparation of the Annual Budget for Calendar Year 2020, Honorable Governor Amado I. Espino, III. proposed that some of the provincial employees should be assigned and given the tasks fit to and based on their basic qualifications and experiences and to cope with the present plans, programs and activities of the new administration;

WHEREAS, the Committees on Appropriations, Economic Affairs and Ways and Means; and Human Resources and Development, Labor and Employment Concerns, after a study of the proposed organization of the provincial government of Pangasinan, find it meritorious to transfer some plantilla positions in order that the various offices/hospital concerned could deliver more effective and efficient duties and responsibilities;

NOW, THEREFORE, on motion of SP Member Angel M. Baniqued, Jr., Chairman of the Committees on Appropriations, Economic Affairs and Ways and Means; and Human Resources and Development, Labor and Employment Concerns, duly seconded -
