## **RESOLUTION NO. 23-2019**

**DECLARING MUNICIPAL ORDINANCE NO. 5, S-2018 OF THE SANGGUNIANG BAYAN OF AGUILAR, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING THE MARKET, SLAUGHTERHOUSE AND OTHER ECONOMIC ENTERPRISES CODE OF THE MUNICIPALITY OF AGUILAR, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Municipal Ordinance No. 5, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer and the Provincial Treasurer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (iii), (3) (i) and (iii), (5) (ii) of RA 7160; and Article 20 of RA No. 7394 or the Consumer Act;

**WHEREAS**, subject ordinance shall take effect after the requirements set forth in Sections 59 and 511 (a) of RA 7160 has been complied with by the Sangguniang Bayan;
