RESOLUTION NO. 23-2021

APPROVING RESOLUTION NO. 2020-200 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "APPROVING AND ADOPTING THE ANNUAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2021 IN THE MUNICIPALITY OF MANGALDAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Resolution No. 2020-200 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out is in consonance to Sections 106, 109 and 114 of RA 7160. The Municipal Development Council of Mangaldan, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for Calendar Year 2021. This was endorsed by the Council to the Sangguniang Bayan through MDC Resolution No. 2, S-2020 dated August 6, 2020;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP was prepared using the prescribed AIP Summary Form, and covers: a) all the regular budgetary requirements for the operations of the different city offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, c) Local Disaster

Risk Reduction and Management Programs/Projects/Activities, and d) Activities in pursuance of the objectives of GAD of the LGU. The AIP of the subject LGU also included projects for funding from external sources. Also attached to the AIP, among others, are the following: a) Local Climate Change Action Plan, CY 2021, b) Peace and Order and Public Safety Plan, CY 2021, c) Municipal Nutrition Action Plan, CY 2021, d) Municipal Tourism and Cultural Development Plan, CY 2021, e) Indicative Annual Procurement Plan, CY 2021, f) List of Programs, Projects/Activities (PPAs) for the Local Council for the Protection of Children, CY 2021, g) List of PPAs for Senior Citizens and Persons with Disabilities, CY 2021, h) List of PPAs for the Prevention and Control of STI, HIV, AIDS, CY 2021, and i) List of PPAs to Address the Problem on Illegal Drugs, or Municipal Anti-Drug Abuse Plan of the LGU;

WHEREAS, the AIP of Mangaldan for CY 2020 has a total investment requirement amounting to P11,757,858,719.00. Of this, P360,299,719.00 will be financed by the LGU as embodied in their 2021 Annual Budget passed and approved by their Sangguniang Bayan through Appropriation Ordinance No. 2020-09 dated October 30, 2020. The remaining amount of P11,397,559,000.00 will be outsourced from various Government Agencies (local and national);

WHEREAS, said AIP is in accordance with Section 287 of RA 7160. More than twenty percent (20%) of the LGU's IRA (P259,284,119.00), amounting to P52,000,000.00 is allocated for development projects;

WHEREAS, the development projects proposed to be funded by the 20% development fund were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the programs and projects included in the 5% Local Disaster Risk Reduction and Management Investment Plan/Program, amounting to P16,505,000.00, were already reviewed by the Office of the Civil Defense-Regional Office I as part of their Six-Year LDRRM Plan (2019-2025) and the LGU was advised to consider to adopt the necessary amendments to the Plan and submit the revised Plan to the OCD-RO1;

WHEREAS, the Gender and Development Plan and Budget (2020) of the municipality has been reviewed and approved by the Department of Interior and Local Government (DILG) Provincial Office, and found to be compliant in form and contents with the provisions of the Joint Memorandum Circular No. 2016-01: Amendments to JMC 2013-01 re: Guidelines on the Localization of Magna Carta of Women;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mangaldan;


