APPROVING SB RESOLUTION NO. 60, S-2021 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 05 CY 2021 AMOUNTING TO THIRTEEN MILLION SIX HUNDRED SIXTY SEVEN THOUSAND FIVE HUNDRED PESOS AND 25/100 (P13,667,500.25) FUNDED BY THE GENERAL FUND AND MUNICIPAL DEVELOPMENT FUND CY 2021 OF THE MUNICIPALITY OF BANI, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its SB Resolution No. 60, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Local Development Council of Bani, Pangasinan had identified items in this Supplemental Investment Program No. 5 CY 2021 which was endorsed to the Sangguniang Bayan for approved on December 13, 2021 through MDC Resolution No. 2021-10;

WHEREAS, Supplemental Investment Program No. 5 covers fund augmentation for the Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices and implementation of disaster risk reduction programs and development projects of the municipality;

WHEREAS, funding support for the implementation of the same in the amount of P13,667,500.25 is embodied in their Supplemental Budget No. 05 CY 2021, which was enacted by the Sangguniang Bayan on December 14, 2021 through Appropriation Ordinance No. 06, S-2021 and approved by the Municipal Mayor on December 31, 2021;


