RESOLUTION NO. 236-2021

DECLARING MUNICIPAL ORDINANCE NO. 09-2020 OF THE SANGGUNIANG BAYAN OF MANAOAG, PANGASINAN, ENTITLED "AN ORDINANCE REQUIRING THE MANDATORY USE OF FACE SHIELD BY ALL PERSONS WHO ARE WITHIN THE JURISDICTION OF THE MUNICIPALITY OF MANAOAG, PANGASINAN DURING THE COMMUNITY QUARANTINE AND EXTENSION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Manaoag, Pangasinan submitted its Municipal Ordinance No. 09-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991:

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 16 and 447 (a) (1) (iii), (5) (xii) of RA 7160; DILG Memorandum Circular No. 2020-071; Provincial Ordinance No. 242-2020 and the Omnibus Guidelines on the Implementation of Community Quarantine;

WHEREAS, subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 and 511 of RA 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Jeremy Agerico B. Rosario and Liberato Z. Villegas and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –
