APPROVING RESOLUTION NO. 096-2018 OF THE SANGGUNIANG BAYAN OF NATIVIDAD, PANGASINAN, ENTITLED “APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) NO. 1 OF THE MUNICIPALITY OF NATIVIDAD, PROVINCE OF PANGASINAN FOR CY-2019”

WHEREAS, the Sangguniang Bayan of Natividad, Pangasinan submitted its Resolution No. 096-2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Natividad, Pangasinan has formulated the municipality’s Annual Investment Program for CY 2019 and endorsed thru MDC Resolution No. 3-2018 dated September 17, 2018 to the Sangguniang Bayan for approval. This was subsequently approved by their Sangguniang Bayan thru Resolution No. 096-2018 dated December 17, 2018. This is in consonance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-

DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Natividad, Pangasinan was formulated following the prescribed AIP Summary Form categorized into general public, social, economic and other service sectors and covers: a) all the regular budgetary requirements for the operation of the different municipal offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, c) Disaster Risk Reduction Management Programs/Projects/Activities of the municipality. It also includes as an integral part the following: 1) Gender and Development Plan, Peace and Order Plan, Local Climate Change Action Plan and 2) list of programs/projects for the Local Council for the Protection of Children, Senior Citizens and Persons with Disabilities and to combat AIDS;

WHEREAS, the AIP has a total investment requirement amounting to P808,761,772.00. Of this, P101,577,772.00 will be funded from the municipality's proposed 2019 Annual Budget which was passed and approved by their Sangguniang Bayan on December 17, 2018 through Appropriation Ordinance Nos. 05-2018 and 06-2018, and P707,184,000.00 will be funded from the Assistance to Municipalities of the DILG and from various national government agencies;

WHEREAS, twenty percent (20%) of the municipality's IRA (P95,287,722.00) for CY 2019 amounting to P19,057,544.00 is allocated for development projects. This is in accordance with Section 287 of RA 7160;

WHEREAS, the identified development programs/projects to be funded by the 20% of IRA were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the LGU has also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;

WHEREAS, the Gender and Development Plan of the municipality was already reviewed by the Department of Interior and Local Government (DILG) and found fully compliant in form and contents with the provisions of the Joint Memorandum Circular No. 2016-01: Amendments to JMC 2013-01 re: Guidelines on the Localization of Magna Carta of Women as per attached Certificate of Review and Endorsement of the DILG issued on March 12, 2018;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
