ALLOWING THE ESTABLISHMENT OF A PARTNERSHIP BETWEEN THE PROVINCIAL GOVERNMENT OF PANGASINAN AND DM CONSUNJI INC. FOR THE CONDUCT OF A BASIC 10-DAY INTENSIVE SKILLED TRAINING PROGRAM IN THE PROVINCE OF PANGASINAN

WHEREAS, DM Consunji Inc. submitted to the Province of Pangasinan a proposed partnership that will set up an understanding between the Provincial Governor and the former in providing a gainful construction career employment opportunity for the people of Pangasinan;

**WHEREAS**, the Program is designed for the conduct of a basic 10-day intensive training on masonry-track or carpentry-track cosurse for Pangasinenses in order for the trainees to obtain fundamental skills, not to mention also the Php200.00 daily allowance they will be receiving during the training;

WHEREAS, it is worthy to note that after the training, a one-month apprenticeship program with full pay is already in the offing for the trainees and their eventual hiring as regular employees at designated DMCI project sites if they qualify the assessment for the National Certification Level II of the TESDA;

**WHEREAS**, there is an urgency and necessity in forging a partnership between the Province of Pangasinan and DM Consunji Inc. for the realization of the viable program;
