RESOLUTION NO. 241-2019

DECLARING THE ANNUAL BUDGET FOR CALENDAR YEAR 2019 OF SAN FABIAN, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P197,013,995.00 OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Annual Budget for Calendar Year 2019 involving total appropriations of **P197,013,995.00** which was approved on December 10, 2018 through Appropriation Ordinance No. 1, S-2018;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. The full implementation of the Fourth Tranche Compensation Adjustment for municipal officials and employees shall be subject to the provisions of Local Budget Circular No. 118 of the Department of Budget and Management dated January 15, 2019;

2. The projects funded under the 20% of the Annual Internal Revenue Allotment for development projects (20% Development Fund) shall be subject to the provisions of DILG and DBM JMC No. 2017-1 dated February 22, 2017 re “Updated Guidelines on the Appropriation and Utilization of the twenty percent (20%) of the Annual Internal Revenue Allotment for Development Projects” and DILG Memorandum Circular No. 2010-138 dated December 2, 2010, entitled “Use of the 20% Component of the Annual Internal Revenue Allotment Shares”;
3. The items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with RA No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Risk Reduction and Management Fund (LDRRMF);
4. All procurements to be undertaken shall be subject to the pertinent provisions of RA No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;
5. The effect of the adjusted FY 2019 Internal Revenue Allotment (IRA) shares pursuant to Local Budget Memorandum No. 77-B dated December 21, 2018, particularly the decrease of the IRA of the LGU amounting to P254,130.00, will necessitate the prioritization in the implementation of items of appropriations;
and
6. The account under Other Personnel Benefits under the Non-Office shall be transferred to Personal Services pursuant to Local Budget Circular No. 98 dated October 14, 2011. The same shall be disbursed in accordance with the rules and regulations to be issued by the proper authorities.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the same in order provided that the above-findings shall be complied with by the municipality and shall notify the offices concerned of the actions taken thereon;
