APPROVING MUNICIPAL RESOLUTION NO. 127-2018 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 2, SERIES OF 2018 OF ANDA, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Municipal Resolution No. 127-2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Anda, Pangasinan had identified items in their Supplemental Investment Program No. 2 for CY 2018 with a total investment requirement of P669,374.96. This was endorsed to the Sangguniang Bayan for approval on December 14, 2018 thru MDC Resolution No. 04, S-2018 and was favorably acted upon by the Sangguniang Bayan on December 27, 2018 thru SB Resolution No. 127-2018;

WHEREAS, the Supplemental Investment Program No. 2 of the municipality covers the granting of Collective Negotiations Agreement Incentives to qualify municipal officials and employees;
