RESOLUTION NO. 243-2021

DECLARING ORDINANCE NO. 21-01 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING PARAGRAPH 4, AND SECTIONS 5 AND 7 OF ORDINANCE NO. 18-15, ENTITLED: "AN ORDINANCE ESTABLISHING THE CITY HEALTH OFFICE CLINICAL LABORATORY OF SAN CARLOS CITY, PANGASINAN AND DEFINING ITS FUNCTIONS, OPERATIONS AND ADMINISTRATION" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Ordinance No. 21-01 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 129, 132 and 458 (a) (5) of RA 7160;

WHEREAS, subject ordinance shall take effect after compliance with the requirements of public hearing and publication pursuant to Sections 187 and 188 of RA 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Vici M. Ventanilla and Angel M. Baniqued, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –




