**APPROVING SB RESOLUTION NO. 68, S-2018 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 03 CY 2018 FUNDED BY THE GENERAL FUND AND 20% MUNICIPAL DEVELOPMENT FUND OF BANI, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Bani, Pangasinan submitted its SB Resolution No. 68, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Bani, Pangasinan had identified items in their Supplemental Investment Program No. 3 for CY 2018. This was endorsed to the Sangguniang Bayan for approval on November 8, 2018 thru MDC Resolution No. 2018-09 and was favorably acted upon by the Sangguniang Bayan on November 26, 2018 thru SB Resolution No. 68, S-2018;

**WHEREAS**, the Supplemental Investment Program No. 3 of the municipality covers fund augmentation for Personal Services and Maintenance and Other Operating Expenses of municipal offices and the implementation of development project;

**WHEREAS**, the Supplemental Investment Program No. 3 has a total investment requirement of P12,050,658.00. Out of which, P8,404,000.00 will be funded by Supplemental Budget No. 02, CY 2018 which was approved and enacted by their Sangguniang Bayan on November 26, 2018 thru Appropriation Ordinance No. 04, S-2018 and approved by the Municipal Mayor on December 14, 2018 and the remaining P3,646,658.00 will be funded from the realigned portion of 20% development fund from the previously approved CY 2018 AIP of the municipality;
