APPROVING RESOLUTION NO. 80-2021 OF THE SANGGUNIANG BAYAN OF SAN JACINTO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 3 CY 2021 OF THE MUNICIPALITY OF SAN JACINTO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of San Jacinto, Pangasinan submitted its Resolution No. 80-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Local Development Council of San Jacinto, Pangasinan has prepared the municipality's Supplemental Investment Program No. 3 for CY 2021 which was endorsed to the Sangguniang Bayan for approved on December 10, 2021 through MDC Resolution No. 2021-04;

WHEREAS, said Supplemental Annual Investment Program which has a total investment requirement of P42,852,183.00, covers augmentation funds for Personal Services, MOOE and Capital Outlay of the LGU, to include the granting of Service Recognition Incentive (SRI) to qualified personnel of the LGU, and financial and infrastructure support to farmers of the municipality;

WHEREAS, funding for the Supplemental AIP is embodied in the Supplemental Budget No. 3 CY 2021, which was enacted by the Sangguniang Bayan on December 23, 2021 through Appropriation Ordinance No. 2021-04;
