PROVINCIAL ORDINANCE NO. 247-2020

AN ORDINANCE TRANSFERRING PLANTILLA ITEM FROM ONE OFFICE TO ANOTHER AND CHANGE OF POSITION TITLE IN THE SOME OFFICES IN THE PROVINCIAL GOVERNMENT

WHEREAS, Section 76 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirement and financial capability, subject to the minimum standard and guidelines prescribed by the Civil Service Commission;

WHEREAS, Section 468 (a) (viii) of the same Code provides that the Sangguniang Panlalawigan has the power to determine the positions and salaries including allowances and other emoluments and benefits of employees of the provincial government;

WHEREAS, in the preparation of the Annual Budget for Calendar Year 2021, Honorable Governor Amado I. Espino, III proposed that some of the plantilla positions should be assigned and given the tasks fit to and based on their basic qualifications and experiences and to cope with the present plans, programs and activities of the new administration;

WHEREAS, the Committees on Appropriations, Ways and Means, and Human Resources and Development, Labor and Employment Concerns, after a study on the proposed organization of the provincial government of Pangasinan, find it meritorious to change the position title in some provincial departments in order that the various offices concerned could be more dynamic and deliver more effective and efficient duties and responsibilities;
