APPROVING RESOLUTION NO. 199, S-2019 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, "APPROVING THE **SUPPLEMENTAL** ENTITLED INVESTMENT PROGRAM OF THE MUNICIPALITY OF BAUTISTA, PROVINCE OF PANGASINAN FUNDED UNDER SUPPLEMENTAL BUDGET NO. 1 FOR CY 2019 AMOUNTING TO THIRTEEN MILLION HUNDRED SIXTY THREE THOUSAND SIX HUNDRED EIGHTEEN PESOS AND 80/100 (P13,863,618.80)"

WHEREAS, the Sangguniang Bayan of Bautista, Pangasinan submitted its Resolution No. 199, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Bautista, Pangasinan has formulated the municipality's Supplemental Investment Program No. 1 for Calendar Year 2019 and endorsed to the Sangguniang Bayan for approval thru MDC Resolution No. 01, S-2019 dated February 4, 2019. This was subsequently approved by their Sangguniang Bayan thru Resolution No. 199, S-2019 dated February 11, 2019. This is in pursuance to Sections 106, 109 and 114 of RA 7160;
