**APPROVING RESOLUTION NO. 095-2018 OF THE SANGGUNIANG BAYAN OF NATIVIDAD, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 2 OF THE MUNICIPALITY OF NATIVIDAD, PROVINCE OF PANGASINAN FOR CY-2018"**

**WHEREAS**, the Sangguniang Bayan of Natividad, Pangasinan submitted its Resolution No. 095-2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Natividad, Pangasinan has formulated the municipality's Supplemental Investment Program No. 2 and endorsed to the Sangguniang Bayan for approval thru MDC Execom Resolution No. 04-2018 dated November 8, 2018. This was subsequently approved by their Sangguniang Bayan thru Municipal Resolution No. 095-2018 dated November 19, 2018;

**WHEREAS**, the Supplemental Investment Program No. 2 of the municipality with an investment requirement of P2,000,711.28 covers the fund augmentation for Maintenance and Other Operating Expenses, and disaster risk reduction management activities of the municipal government;


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
