APPROVING RESOLUTION NO. 2021-242 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED, "CONFIRMING/APPROVING IN TOTO THE PROPOSED CY 2021 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 07 OF THE CITY OF ALAMINOS, PANGASINAN AMOUNTING TO EIGHT MILLION TWO HUNDRED SIX THOUSAND ONE PESOS AND SIXTY-THREE CENTAVOS (P8,206,001.63)"

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Resolution No. 2021-242 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R. A. 7160;

WHEREAS, the Local Development Council of Alaminos, Pangasinan had identified items in this Supplemental Investment Program No. 07 CY 2021 which was endorsed to the Sangguniang Panlungsod for approval on December 27, 2021 through CDC Executive Committee Resolution No. 09, S-2021;

WHEREAS, Supplemental Investment Program No. 07 covers fund augmentation for Personal Services (granting of Service Recognition Incentive for the officials and employees of the City Government of Alaminos) and Maintenance and Other Operating Expenses of some of the offices of the City of Alaminos;
