RESOLUTION NO. 255-2022

DECLARING ORDINANCE NO. 174, S-2022 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 71, S-2015 "AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 71-S-2015 "AN ORDINANCE DECLARING SEPTEMBER 5, FOUNDATION DAY OF BASISTA, PANGASINAN, AS THE TOWN FIESTA OF BASISTA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 174, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the power of the Sangguniang Bayan to enact and approve resolutions carries with it the power to amend, revoke modify or repeal the same;

WHEREAS, however, the Sangguniang Bayan shall consider the points raised by the Provincial Legal Officer stated in her opinion dated February 11, 2022;

WHEREAS, subject ordinance shall take effect after compliance with the requirements of posting pursuant to Section 59 (c) of R. A. No. 7160;


