**APPROVING RESOLUTION NO. 088-2021 OF THE SANGGUNIANG BAYAN OF LABRADOR, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND INVESTMENT PROGRAM (LDRRMFIP) OF THE MUNICIPALITY OF LABRADOR, PANGASINAN FOR CY 2021"**

**WHEREAS**, the Sangguniang Bayan of Labrador, Pangasinan submitted its Resolution No. 088-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Supplemental Local Disaster Risk Reduction and Management Fund Investment Program (LDRRMFIP) CY 2021 of the Municipality of Labrador was endorsed by the Local Risk Reduction and Management Council on November 22, 2022 through MDRRMC Resolution No. 001-S-2021;

**WHEREAS**, Supplemental LDRRMFIP covers COVID-19 related programs and projects and disaster reduction and mitigation projects proposed to be funded from the unexpended balances of their LDRRM Fund CYs 2016 and 2017 (Trust Fund). The utilization of the trust fund for the above purposes is in accordance with Item 2.5.5 of Local Budget Circular No. 124, dated March 26, 2020;

**WHEREAS**, Resolution No. 088-2021 of the of the Sangguniang Bayan of Labrador, the Supplemental LDRRMFIP was integrated in the Revised Annual Investment Program CY 2021, and this is in accordance with Item 6.5 of NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 of the Department of the Interior and Local Government;
