PROVINCIAL ORDINANCE NO. 257-2021

AMENDING PROVINCIAL ORDINANCE NO. 254-2020 OF THE SANGGUNIANG PANLALAWIGAN, ENTITLED “AN ORDINANCE PRESCRIBING SPECIFIC GUIDELINES FOR THE REOPENING OF TOURISM IN THE PROVINCE OF PANGASINAN AMID COVID-19 PANDEMIC” PARTICULARLY SECTION 6.A.6 THEREOF

WHEREAS, Provincial Ordinance No. 254-2020 of the Sangguniang Panlalawigan, approved on December 17, 2020, prescribed the specific guidelines for the reopening of tourism in the Province of Pangasinan amid COVID-19 pandemic;

WHEREAS, Section 6.A.6 thereof provides for guidelines for tourists allowed in the Province except for those from MECQ and ECQ areas within or outside Region I;

WHEREAS, due to the increasing number of confirmed COVID-19 cases and in order to avert the threat of possible entry of UK variant in the Province which might compromise the reopening of its tourism industry, there is a need to amend Provincial Ordinance No. 254-2020 to also exclude tourists from GCQ areas;

WHEREFORE, in view of the foregoing, on motion of SP Member Margielou Orange D. Humilde-Verzosa, duly seconded, it was -

Be it enacted by the Sangguniang Panlalawigan in session assembled:

Section 1. Title. – This Ordinance shall be known as An Ordinance amending Provincial Ordinance No. 254-2020 of the Sangguniang Panlalawigan, entitled “An Ordinance Prescribing Specific Guidelines for the Reopening of Tourism in the Province of Pangasinan amid COVID-19 Pandemic” particularly Section 6.A.6 thereof;

Section 2. Amendment. – Section 6.A.6 thereof shall now read as follows:


“Tourists from GCQ, MECQ and ECQ areas within or outside Region I”
