APPROVING RESOLUTION NO. 18-113 OF THE SANGGUNIANG PANLUNGSOD OF THE CITY OF SAN CARLOS, PANGASINAN, ENTITLED “APPROVING AND ADOPTING THE ANNUAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2019 OF THE CITY GOVERNMENT OF SAN CARLOS (PANGASINAN)”

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 18-113 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The City Development Council of San Carlos, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for CY 2019. This was endorsed by the Council to the Sangguniang Panlungsod thru CDC Resolution No. 16-18 (Series of 2018) dated October 10, 2018 and was favorably acted upon by the Sangguniang Panlungsod on December 3, 2018 thru SP Resolution No. 18-113;

WHEREAS, the Annual Investment Program of the city is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC

No. 2015-01 dated July 23, 2015 as to format and content. The AIP of San Carlos City, Pangasinan was prepared using the prescribed AIP Summary Form, and covers: a) all the regular budgetary requirements for the operation of the different offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, c) Disaster Risk Reduction (DRR) Programs/Projects/Activities, and d) Activities in pursuance of the objectives of GAD. Also attached to the AIP are the following: a) Programs/Projects/Activities to be funded by external sources, b) Local Climate Change Action Plan, c) Peace and Order Plan, d) List of Programs/Projects/Activities for the Local Council for the Protection of Children, and e) Programs/Projects/Activities for Senior Citizens and Persons with Disabilities;

WHEREAS, the AIP of San Carlos City for CY 2019 has an investment requirement of P803,110,687.86. Funding support for the implementation of the AIP is embodied in their 2019 Annual Budget passed and approved by the Sangguniang Panlungsod through Appropriation Ordinance No. 18-14 dated December 3, 2018;

WHEREAS, said AIP is in accordance with Section 287 of RA 7160. Twenty percent (20%) of the LGUs IRA (P673,959,735.00) which is equivalent to P134,791,947.00 is allocated for development projects;

WHEREAS, the development projects proposed to be funded by the 20% development fund were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the projects and activities included in the 5% Local Disaster Risk Reduction and Management Fund amounting to P38,196,297.65 are in accordance in accordance to Section 21 of RA 10121 and NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund);

WHEREAS, the Gender and Development Plan and Budget for CY 2019 has been reviewed by the Department of Interior and Local Government (DILG) Provincial Office, and were found to be fully compliant in form and in contents with the provisions of the DBM, PCW, DILG & NEDA Joint Memorandum Circular No. 2016-01 entitled "Amendments to JMC 2013-01 or the Guidelines on the Localization of Magna Carta of Women";


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
