**APPROVING RESOLUTION NO. 2020-007 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED “APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) CY 2020 OF SUAL, PANGASINAN AMOUNTING TO FOUR HUNDRED SIX MILLION PESOS (P406,000,000.00)”**

**WHEREAS**, the Sangguniang Bayan of Sual, Pangasinan submitted its Resolution No. 2020-007 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Municipal Development Council of Sual, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for CY 2020. This was endorsed by the Local Development Council to the Sangguniang Bayan thru MDC Resolution No. 02, S-2019 dated September 27, 2019 and was favorably acted upon by the Sangguniang Bayan on January 20, 2020 thru SB Resolution No. 2020-007;

**WHEREAS**, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Sual, Pangasinan was formulated following the prescribed AIP Summary Form, and covers: a) all the regular budgetary requirements for the operation of the different offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20%

development fund, c) Disaster Risk Reduction (DRR) Programs/Projects/Activities, d) Peace and Order Plan, e) Gender and Development Plan, f) Nutrition Action Plan, and g) list of programs, projects and activities for the Local Council for the Protection of Children, Senior Citizens and Persons with Disabilities, and PPAs to combat AIDS and to address the problems of illegal drugs,

**WHEREAS**, the AIP of Sual for CY 2020 has a total investment requirement of P406,000,000.00. Funding support for the implementation of which is embodied in their 2020 Annual Budget in the amount of P395,000,000.00 which passed and approved by the Sangguniang Bayan through Appropriation Ordinance No. 01 dated January 20, 2020. The remaining amount of P11,000,000.00 is proposed for funding from the DILG through the Local Government Support Fund- Assistance to Municipalities Program of the agency;

**WHEREAS**, this AIP is in accordance with Section 287 of RA 7160. Twenty percent (20%) of the LGUs IRA (P124,349,787.00) which is equivalent to P24,869,958.00 is allocated for development projects;

**WHEREAS**, the development projects proposed to be funded by the 20% development fund were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

**WHEREAS**, the Disaster Risk Reduction and Management Investment Plan in preparation for and to mitigate the impact of disasters to be funded by the 5% LDRRM Fund (P19,750,000.00) conforms with Section 21 of RA 10121. The programs, projects and activities to be funded by 70% of the 5% LDRRM Fund in the amount of P13,825,000.00 were based on NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund);

**WHEREAS**, however, the LDRRM Plan of the municipality shall be submitted to the Office of Civil Defense for review as per Local Budget Memorandum No. 77 dated May 15, 2018;

**WHEREAS**, the LGU of Sual had also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;
